

Interfraternity Council Recruitment Policies

May 2016

Summer Recruitment

- 1) Summer Recruitment is defined as the period lasting from May 14, 2016 (the last day of finals) to September 2nd, 2016.
- 2) Alcohol may not be present and/or provided at any time at any Summer/Informal Recruitment event. Freshmen males and all registered Potential New Members, regardless of semester standing, may not be present at any events where alcohol is being served. **Any chapter found in violation of these rules will be fined \$1000.00 per event** and will be placed on social moratorium for the entirety of fall semester. If the fine is not paid in full by the end of the social moratorium period, the chapter will remain on social moratorium. Chapters participating in Homecoming or Machy Days may still participate, but will not be allowed to host or attend social functions where alcohol is present.
- 4) All Informal Recruitment Events (excluding events with less than 4 PNMs) must be sent in an email to IFC 2 weeks before the event takes place. **Failure to register any Summer Informal Recruitment Event will result in a fine of \$250.00 and two (2) weeks of social probation.** If a spontaneous event occurs, the IFC VP Recruitment should be contacted immediately. If the fine is not paid in full by the end of the social probation period, the chapter will remain on social probation.
- 5) You may extend a bid or verbal commitment at any time through September 2nd. **Extending a Bid post September 2nd through 5:00pm on September 8, 2016 will result in a \$500.00 fine per extension.**
- 7) All Informal Summer Recruitment Events including dinners, hangouts, events, or anything involving a PNM present must be completely dry. Absolutely no wet recruitment or providing any sort of alcohol to potential new members.
- 8). All Informal Summer Recruitment Events will not include any women present. **Any chapter found in violation of these rules will be fined \$200.00 and two (2) week of social probation.** If the fine is not paid in full by the end of the probation period, the chapter will remain on social probation.

Formal Recruitment

- 1) Formal Recruitment is defined as the period lasting from September 3, 2016 to September 8th, 2016.
- 2) Alcohol may not be present and/or provided at any time at any Formal Recruitment event. Freshmen males and all registered Potential New Members, regardless of semester standing, may not be present at any events where alcohol is being served. **Any chapter found in violation of these rules will be fined \$1000.00 per event** and will be placed on social moratorium for the remainder of fall semester. If the fine is not paid in full by the end of the social moratorium period, the chapter will remain on social probation. Chapters participating in Homecoming or Machy Days may still participate, but will not be allowed to host or attend social functions where alcohol is present.
- 3) All fraternity chapter houses must be open and available for inspection by the Greek Ambassadors and IFC Executives at any and all times throughout Recruitment.
- 4) All Formal Recruitment Events must be registered through the BeGreek website (begreek.org). **Failure to register any Formal Recruitment Event will result in a fine of \$250.00 and two (2) week of social probation.** If the fine is not paid in full by the end of the social probation period, the chapter will remain on social probation.
- 6) Extending a Bid to any Potential New Member prior to 5:00pm on Thursday September 8, 2016, is prohibited. **Extending a Bid prior to 5:00 pm on September 8, 2016 will result in a \$500.00 fine per extension.**
- 8) No tier 2 or tier 3 BYOB events (parties, tailgates, etc.) may be held in the presence of alcohol until the end of formal recruitment on September 8, 2016. Any chapter not in compliance will be placed on social moratorium, for the remainder of fall semester.

Recruitment Materials and Videos

- 1) Alcohol or alcohol related paraphernalia (i.e. red cups) may not be present in any recruitment materials or videos. **Any chapter found in violation of these rules will be fined \$250.00 and will be asked to remove from social media or revise these materials.**
- 2). All Recruitment Materials and Videos will not have any women present. **Any chapter found in violation of these rules will be fined \$250.00 and will be asked to remove from social media or revise these materials.**
